## **Rachel King Passes Away**

It is with great sadness that we report the passing of Rachel Carol King, 45, the first executive director of Alaskans Against the Death Penalty, and an ardent and lifelong abolitionist. Rachel died on August 25th of breast cancer at her summer home in Wayne, Maine. She lived in Washington and was employed as a lawyer for the U.S. House Judiciary Committee's Subcommittee on Crime and Homeland Security.

Rachel was born in Enid, Okla., and moved to Wayne as a child. She graduated from Smith College in Massachusetts and then worked for the Girl Scouts of America in Massachusetts while volunteering in the Sanctuary movement, a religious and political movement that sheltered Central American refugees. She received a law degree in 1990 from Northeastern University in Boston. Rachel worked as a lawyer in Alaska from 1990 until 1996, at the Public Defender offices in Ketchikan, Kodiak, and Anchorage. She was also executive director of the Alaska Civil Liberties Union and was active in the state's Green Party.

Rachel moved from Alaska to Philadelphia in 1996, and then to Washington in 1998. She was a legislative counsel and lobbyist for the American Civil Liberties Union, where she worked on limiting the scope of the USA Patriot Act. Rachel was a also founding member of Takoma Village Cohousing in Northwest Washington, where she lived, and

# **Fish Fry Once Again a Success!**



received a master's degree in law in 1998 from Temple University in Philadelphia. She also taught law classes at Howard University.

At the time of her death, Rachel was in a master's degree program in creative writing at Johns Hopkins University. She wrote <u>Don't Kill in Our Names:</u> <u>Families of Murder Victims Speak Out Against the Death Penalty</u> (2003) and <u>Capital Consequences:</u> <u>Families of the Condemned Tell Their Stories</u> (2005). She published a novel, <u>Tales of the District</u>, last year.

Rachel, a Quaker, had been the chairwoman of the National Coalition to Abolish the Death Penalty. NACDP announced in July that it planned to give her its lifetime achievement award. Rachel was a photographer and a long-distance runner, and she competed in more than a dozen marathons, including the Boston Marathon.

Survivors include her husband of three years, Richard G. McAlee of Washington; three stepdaughters, Lauren McAlee of Washington, Julia McAlee of Olympia, Wash., and Livia McAlee of Crofton; her



#### Troy Davis Given a Stay Less Than 2 Hours Before His Execution!



Troy Davis was scheduled to be executed on September 23, 2008, for the murder of Police Officer Mark MacPhail in Georgia, but the U.S.

Supreme Court granted a stay of execution less than two hours before it was to be carried out. The court's nine justices then met in conference on Sept. 29 to decide whether to accept the appeal. Now, they will meet once more to discuss the case. The court did not say when it will issue a decision. Serious doubts of his guilt remain and compelling evidence of his innocence has not been heard in court.
