





## Bill is taking the Journey of Hope to UGANDA!

Here is Bill's message:

Members of Alaskans Against the Death Penalty have always been very supportive of me and the Journey of Hope - *from Violence to Healing*. Once again, I am asking for your help to make a difference in the World. The Journey is going to **Uganda October 4-13th**. Edward Edmary Mpagi asked me to bring the Journey to his country and help him in his

battle for abolition of the death penalty. Edward was sentenced to death and spent 20 years in a Ugandan prison. He was released and exonerated when it was proven that the purported victim had been alive many years after his supposed death. Edward is now building a school in Kampala for

children of death row inmates and other poor prisoners.

Edward joined the Texas Journey of Hope in 2007 when he visited the United States. Amnesty International, London, brought Edward to the United States to address the United Nations. Edward flew to Texas and joined the Journey in San Antonio following his talk at the UN. He journeyed with us on to Austin and Dallas. A bond with the Journey was formed. He now fights a lonely battle in Uganda.

#### **Troy Davis Execution Set for September 21**



An execution warrant <u>setting Troy Davis' execution</u> has been signed by a Chatham County judge. The execution date has now been set for <u>September 21st</u>.

An execution is NOT inevitable. This merely sets the clemency process in motion. Before September 21, the Georgia State Board of Pardons and Paroles will rule on whether Troy Davis' sentence should be commuted, or whether the execution should be carried out as scheduled. Previously, the Board stated that it would not allow an execution unless there was "no doubt" as to guilt.

Amnesty International will call an **International Day of Solidarity for Troy Davis** once a little bit more about the plans of the Parole Board are known.


#### Too Much Doubt

Troy Davis was convicted of murdering a Georgia police officer in 1991. Nearly two decades later, Davis remains on death row — even though the case against him has fallen apart.

The case against him consisted entirely of witness testimony which contained inconsistencies even at the time of the trial. Since then, all but two of the state's non-police witnesses from the trial have recanted or contradicted their testimony.

Many of these witnesses have stated in <u>sworn affida-vits</u> that they were pressured or coerced by police into testifying or signing statements against Troy Davis.

One of the two witnesses who has not recanted his testimony is Sylvester "Red" Coles - the principle alternative suspect, according to the defense, against whom there is new evidence implicating him as the gunman. Nine individuals have signed affidavits implicating Sylvester Coles.
