In March Alaskans Against the Death Penalty hosted David Kaczynski, brother of the so-called "Unabomber," and his wife, philosophy professor, Dr. Linda Patrik, who spoke about how they came to the realization that David's brother, Ted, might be the "Unabomber," their ultimate decision to talk to the FBI, and their struggle to ensure that Ted would not receive the death penalty.

Bill Babbitt, also turned in his brother, Manny Babbitt-a decorated Vietnam Vetand spoke about his ethical and emotional journey. Unfortunately, his brother was executed by the State of California.

## ALASKANS AGAINST THE DEATH PENALTY IS HONORED TO WELCOME RAIS BHUIYAN – JOURNEY OF HOPE - TO ANCHORAGE

**Rais Bhuiyan**, a Muslim immigrant from Bangledesh, worked as a cashier at a convenience store and was the vicitim of a post 9/11 shooting spree. Mark Stroman was his attacker. Mr. Stroman, an avowed white supermacist and methamphetamine addict, was caught and confessed to the shooting as well as two others. The other men died. Although Rais, survived he was blinded in one eye and still carries 35 shotgun pellets embedded in his face. Mr. Stroman died on death row July 2011.

**Mr. Bhuiyan** advocated to spare his attacker's life. He mounted an aggressive campaign to convince Texas authorities to commute Stroman's sentence to life in prison without the possiblity of parole.

**Mr. Bhuiyan** in an interview with the HuffPost, said his efforts on behalf of Stroman were motivated by his Muslim faith. Mr. Bhuiyan's message of forgiveness changed Mr. Stroman's life and it can change yours. Please join us in welcoming Mr. Bhuiyan to Alaska.

## David Kaczynski, brother of the "Unabomber," spoke to students at UAA for the National Criminal Justice Month kickoff event March 1

David Kaczynski, brother of the so-called "Unabomber," spoke to about 80 students and members of the public at the kickoff event for National Criminal Justice Month on March 1 on campus. Mr. Kaczynski and his wife, philosophy professor, Dr. Linda Patrik, talked about how they came to the realization that David's brother, Ted, might be the "Unabomber," their ultimate decision to talk to the FBI, and their struggle to ensure that Ted would not receive the death penalty.

While sharing his personal story of growing up with his brother, Ted, Mr. Kaczynski described how his involvement in his brother's trial led him to his work as Executive Director for New Yorkers for Alternatives to the Death Penalty and his efforts to improve rehabilitation and reentry services for prisoners. ## Great Chili from the Chili Feed

ENJOY!

- 1 pound ground beef
- 1 <u>onion</u>, chopped
- 1 (14.5 ounce) can stewed tomatoes
- 1 (15 ounce) can <u>tomato</u> sauce
- 1 (15 ounce) can kidney beans
- 1 1/2 cups water
- 1 pinch chili powder
- 1 pinch <u>garlic</u> powder
- salt and pepper to taste

Directions

- In a large saucepan over medium heat, combine the beef and onion and sauté until meat is browned and onion is tender. Add the stewed tomatoes with juice, tomato sauce, beans and water.
- Season with the chili powder, garlic powder, salt and ground black pepper to taste. Bring to a boil, reduce heat to low, cover and let simmer for 15 minutes.
